#### About WDC:

# 1. For Activity (i) - Supply of Sanitary Napkins

### Envelope marked "A"-

- i) Proof of being the Manufacturer of the product. If the agency is the supplier of the product, authorization letter from the manufacturer is to be submitted
- ii) Past performance of supply of similar nature to any Govt. / Public Sector agency/ Corporate House / International agency
- iii) Copy of VAT registration and latest VAT return copy.
- iv) Copy of all other statutory registration papers
- v) Copy of PAN and IT return copy of last 3 financial years.
- vi) A self declared affidavit that the firm has not been blacklisted for any cause by Government of India / Govt of Bihar or any other Public Sector Agency..



# For Activity (ii) - Skill training & Awareness Creation :- specialization in health sector

#### Back ground -

About 52% of the female population is of reproductive age and most of them are menstruating every month. The majority of them have no access to clean and safe sanitary products, or to a clean and private space in which to change menstrual cloths or pads and to wash.

Menstruation is supposed to be invisible and silent, and sometimes, menstruating women and girls are supposed to be invisible and silent, too. Millions of girls and women are subject to restrictions in their daily lives simply because they are menstruating. Besides the health problems due to poor hygiene during menstruation, the lack or unaffordability of facilities and appropriate sanitary products may push menstruating girls temporarily or sometimes permanently out of school, having a negative impact on their right to education. The best place to make an impact on improving the lives of girls and women is in water and sanitation. The time has come to promote —loudly and unashamedly — the role of good Menstrual Hygiene Management (MHM) as a trigger for better, stronger development of women and girls: personal, educational and professional. There is also clear evidence to show that ignoring good menstrual hygiene is damaging not just women and girls directly but also for schools, businesses and economies.

# Objective of the Assignment- The objective of the Assignment is to

Improving lives of Women and Adolescent by Creating awareness about the menstrual Hygiene Management among the Women and Child ,promote the use of Sanitary Napkin ,its disposal and Creating a supply chain for availability of the affordable Sanitary Napkin and creating awareness about the water and Sanitation .

#### Scope of Work-

a) The agency has to train and develop master trainers at the Block and district level who can create awareness among the adolescent girls and women about the menstrual Hygiene management.

b) Piloting Establishment of Incinerator and Vending Machine in Schools and Colleges by assisting Women Development Corporation.

c) Develop Supply Chain of Low Cost Sanitary Napkins in the Block and at Federation Level.

d) Manage the Training of the Trainers at the SHG level who will create awareness at the Panchayat level about the Menstrual Hygiene management.

e) Creating Awareness through distribution of IEC materials .

## Support By Women development Corporation -

1. Women Development Corporation will provide cost of two manpower at the monthly remuneration of Rs.25000/- per month to manage and execute the project.

- 3. The Training cost will be decided as per the cost norms of Bihar Skill Development
- 4. The other cost if required will also be reimbursed by the Corporation if it so

## Envelope marked "A"-

- i) Proof of registration with Bihar Skill Development Mission / NSDS / Sector Skill Council in health sector training
- ii) Experience in Training minimum 1000 Paramedical Assistant in Bihar in minimum 5 Districts of Bihar
- iii) Copy of Service tax registration and other statutory registration papers
- iv) In case the bidder is a consortium, then any one of the consortium / association partner must fulfill the above Sl No. i, ii & iii.
- v) A self declared affidavit that the firm has not been blacklisted for any cause by Government of India / Govt of Bihar or any other Public Sector Agency.

One bidder may submit proposal for both the activities (if eligible), but has to submit separate proposal for the activities. The Bidder also should have the capability to distribute the items to the specified destinations i.e. District headquarters (within the State of Bihar) within the stipulated time schedule.

- a. For Activity (i) Supply of Sanitary Napkins

Rates are to be submitted as per Annexure 1.

b. For Activity (ii) - Skill training: - specialization in health sector

No financial bid has to be submitted. The activity will be done as per the BSDM cost norms.

Envelopes marked 'A' will be opened first and the contents will be evaluated at first stage. The financial bid of those bidders will only be opened, whose documents will be found satisfactory and according to instruction and specification.

The empanelment is proposed for a period of 01 year, which may be terminated by either side by giving a 01 month notice. Any extension beyond the period of 01 year will be done based on the performance of the agency and need of the programme, maximum for 2 more years.

Bidders are requested to send their offer in the prescribed format in sealed envelop addressed to Managing Director, Women Development Corporation, Bihar, 2<sup>nd</sup> Floor Indira Bhawan, R.C Singh Path, Patna on or before 19.12.2016, 3.00 PM.
