Bid Guideline for Hiring the service Travel Agency

Sealed tender under 2 bid system is invited from registered travel agents for providing vehicle service. Vehicles are required on both monthly and hourly basis. The empanelment is proposed for a period of one year which may be extended by one more year based on the performance of the agency and need for the service. Annual rate revision, if any, will be maximum upto 10 % provided there may be substantial revision in the cost of fuel and wage rate during the year.

If required, the Corporation may empanel more than one agency. In such case, the empanelment rate will be fixed on the basis of the least quoted rate for the particular category.

I. The brief Scope of Service is as follows:

- 1. Vehicles on monthly and hourly basis are to be provided. The current requirement of vehicle for monthly basis is as follows:
 - a. Scorpio / Xylo / Similar SUV category -02 nos
 - b. Car category (Swift desire, Tata Zest, Indigo etc.) 01 no. (the requirement may increase or decrease as per the need)

The monthly hired vehicle may be required to work on all 7 days of the week. The requirement of vehicle on hourly basis will be as per need.

- 2. Service of only commercial license vehicles are to be given.
- 3. The vehicle provided by the agency should be maximum two years old, preference will be given to new vehicles.

- 6. Proof of experience in support of para II (6).
- 7. EMD in form of Demand Draft of Rs.50000/-.
- 8. A Self declaration stating that the agency has not been blacklisted by any Government agency / PSU.
- 9. A notarized affidavit stating the agency/firm shall provide commercially registered, GPS enabled less than 2 years old vehicle. If any deviation is found then the client shall be free to take action as legally permitted.



Agency not fulfilling the above para 1 to 9 shall be technically rejected. Agency whose past performance in this Corporation has been poor shall not be entertained.
